

**RELEASE AND INDEMNITY AGREEMENT
RE DANCE KRAZE CLASSES, OPEN CLASSES/WORKSHOPS/PRIVATE
& SEMI-PRIVATE LESSONS AT OPLENAC SERBIAN CULTURAL
CENTER (SCC)**

I have read, understand and voluntarily accept the terms of this Release and Indemnity in exchange for which I will be permitted to be a participant in Dance Kraze Classes, Open Dance Classes/Workshops/Private & Semi-Private Lessons at Oplenac (SCC) [‘Dance Classes’] from August 1st 2011 to August 31st 2012.

I understand that, by participating in the Dance Classes, I will be engaged in recreational activities of considerable risk. I further understand:

- (a) that there are significant risks and dangers involved in recreational activities, including dancing;
- (b) that these risks and others are inherent in recreational activities, including dancing, and may not be anticipated, controlled or eliminated by Dance Kraze Productions, Katarina Corbic, other instructors/assistants and Oplenac (SCC) and further that Dance Kraze Productions, Katarina Corbic, other instructors/assistants and Oplenac (SCC) has no duty to do so;
- (c) that these risks and activities in general can cause property damage, bodily and personal injuries, illness, paralysis and death to me;
- (d) that Dance Kraze Productions, Katarina Corbic, other instructors/assistants and Oplenac (SCC), and/or other people, including other participants may, on occasion, be Negligent (meaning, generally, a failure to exercise ordinary reasonable care) and that this Negligence can also cause property damage, bodily injury and personal injuries, illness, paralysis and death to me.

I hereby release and discharge Dance Kraze Productions, Katarina Corbic, other instructors/assistants and Oplenac (SCC), and their successors or assigns and any corporations associated with or related to Dance Kraze Productions, Katarina Corbic, other instructors/assistants and Oplenac (SCC) and their respective directors, officers, shareholders, employees and agents (collectively referred to as the “Releasees”), from any and all actions, claims, demands, obligations, causes of action, demands, costs, expenses and compensation of any kind on account of or in any way arising out of, or which in the future may result from, participation in the Dance Classes or in conjunction with the Dance Classes or the negligence of Dance Kraze Productions, Katarina Corbic, other instructors/assistants, Oplenac (SCC) and/or other people, including other participants. This Release and Indemnity includes, but is not limited to, all claims or causes of action, whether based on a tort, contract or any other theory or recovery, which I now have or which I may have in the future on account of in any way arising out of my participation in the Dance Classes.

Participant or Parent/Guardian Initial (if 17 & under)

I further agree to hold harmless Dance Kraze Productions, Katarina Corbic, other instructors/assistants and Oplenac (SCC) against loss from any and all claims, demands or actions which may be made or brought against Dance Kraze Productions, Katarina Corbic, other instructors/assistants and/or Oplenac (SCC) by any person or entity who claims to have been damaged or who asserts a claim as a result of property damage, bodily or personal injury, illness, paralysis and/or death to me arising out of the Dance Classes.

I acknowledge and agree that my participation in the Dance Classes is completely voluntary and I acknowledge and accept all risks and assume full responsibility for all risks, including but not limited to the risks identified in this Release and Indemnity and I acknowledge and accept full responsibility for all property damage, bodily and personal injury, illness, paralysis and death to me.

I represent that I have completely and fully read and understand this document, that I agree to its terms, that I have had ample opportunity to seek legal advice to review and advise me as to the legal affect of this Release and Indemnity, and have been provided additional opportunities to ask questions and make enquiries of Dance Kraze Productions regarding this Release and Indemnity.

This Release and Indemnity Agreement will be governed by the laws of Ontario.
